THE MERRY MONEY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE, ACCOUNT, ZELLE® TRANSACTION OR BILL PAY NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, USING ZELLE® OR BILL PAY WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: The Merry Money Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Sunday, November 1, 2020 and ends at 11:59:59 PM ET on Thursday, December 31, 2020 (the "Sweepstakes Period"). Each Financial Institution's database clock will be the official timekeeping device for this Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who have reached the age of majority in their state of residence (18, except in AL & NE – 19 and MS, 21) at the time of entry and businesses that are located within the 50 United States including the District of Columbia. Void outside the U.S., and where prohibited by law and subject to all federal, state and local laws. Employees of Fidelity Information Services, LLC (the "Sponsor") US Sweepstakes & Fulfillment Co (the "Administrator") participating Financial Institutions (the "Financial Institutions"), and each of their respective subsidiaries, affiliates, advertising and promotion agencies (collectively, the "Sweepstakes Entities"), and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter or win. To receive one (1) entry via the Zelle® Transaction method, an authorized account holder of a participating Financial Institution will be required to send one (1) *Zelle* transaction to a recipient using *Zelle* within the online or mobile app offered by that Financial Institution (the "**Zelle® Transaction**" method). Limit: one (1) Zelle® Transaction transaction per *Zelle* recipient. Online and mobile app *Zelle* transactions must be in the amount of \$5 or more. The date and time of the entry will be the date and time that the transaction is processed. Entries must be complete and received during the Sweepstakes Period to be entered into the drawing. Must have a bank account in the U.S. to use *Zelle*.

Method #2: Bill Pay. To receive one (1) entry via the Bill Pay method, an authorized account holder of a participating Financial Institution will be required to pay one (1) bill using the bill pay system offered by that Financial Institution (the "Bill Pay"). Auto payments set up by the authorized account holder prior to the start of the Sweepstakes will not result in a Bill Pay Entry. Limit: one bill

payment per bill payee. Online and mobile app bill payments must be in the amount of \$10 or more. The date and time of the entry will be the date and time that the bill is processed. Entries must be complete and received during the Sweepstakes Period to be entered into the drawing.

Method #3: Alternate Method of Entry. Alternate Method of Entry ("AMOE"). To enter without using Zelle® or using Bill Pay, mail a postcard (the "Mail-In Entry"), including your name, complete address, email address and phone number to the following address to receive one (1) entry into the Sweepstakes:

Each Mail-In Entry must be mailed separately and must be postmarked between Sunday, November 1, 2020 and Thursday, December 31, 2020, and received by Thursday, January 7, 2021. Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

Limit: Thirty (30) entries per person, regardless of method of entry. All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.
